**AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF RUMSON
BY AMENDING CHAPTER VII, TRAFFIC ORDINANCE**

BE IT ORDAINED by the Mayor and Council of the Borough of Rumson, in the County of Monmouth and State of New Jersey that Chapter VII (Traffic), Schedule I No Parking and Schedule II Parking Prohibited Certain Hours of the General Ordinances of the Borough of Rumson is hereby amended or supplemented as follows:

PURPOSE

The purpose of this Ordinance is to Amend Chapter VII (Traffic), Schedule I No Parking, Schedule II Parking Prohibited Certain Hours to amend the parking on Bellevue Avenue in the area of Rumson Country Day School.

Chapter VII (Traffic), Schedule I No Parking and Schedule II Parking Prohibited Certain Hours of the General Ordinances of the Borough of Rumson are hereby amended or supplemented as follows (new text is double underlined, text to be deleted is ~~struck through~~ and notations to the reader and changes in subparagraph designations either with or without changes to content are italicized):

SECTION 1.

That Chapter VII, Traffic Ordinance, Schedule I No Parking shall be amended to as follows:

**CHAPTER VII
TRAFFIC**

**SCHEDULE I
NO PARKING**

In accordance with the provisions of subsection 7-3.3, no person shall park a vehicle at any time upon any of the following described streets or parts of streets.

<i>Name of Street</i>	<i>Side</i>	<i>Location</i>
Bellevue Avenue	West	Between Ridge Road and Auldwood Lane

SECTION 2.

That Schedule II, Parking Prohibited Certain Hours, shall be amended to read as follows:

**SCHEDULE II
PARKING PROHIBITED CERTAIN HOURS**

In accordance with the provisions of subsection 7-3.4, no person shall park a vehicle or dumpster between the hours specified upon any of the following described streets, or parts of streets, or Municipal parking lots.

<i>Name of Street</i>	<i>Side</i>	<i>Hours</i>	<i>Months/Location</i>
Bellevue Avenue	East	From 8:00 a.m. to 8:30 a.m. and 3:00 p.m. to 3:30 p.m. on school days only	Between North Rohallion Drive and 25 feet south of Ridge Road.
Bellevue Avenue	West	From 7:00 a.m. to <u>3:00 p.m. 4:00 p.m.</u> on school days only	From 25 feet north of Ridge Road to Auldwood Lane

SECTION 3.

If any section, subsection, clause, or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the remaining portions of this ordinance. All

ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4.

This ordinance shall take effect upon final passage and publication according to law.
