- **Karl**, 17 Heathcliff Road, B119, L5, Zone: R-1 *(Rescheduled, will readvertise)*  
Proposed improvements consist of a rear addition to the existing nonconforming dwelling on a nonconforming lot. Requested relief: permission to expand a nonconforming dwelling, bulk "c" variances in connection with: front yard setback, lot coverage, and existing lot area.
- **#26-8111\_Fox-Karnal**, 15 Sycamore Lane, B86, L12, Zone: R-1 *(Denied)*  
Proposed use consists of keeping farm animals and related accessory structures on a residential property. Relief requested: Use variance ("d") and bulk variances ("c") in connection with accessory structure setbacks.
- **#26-8112\_Undici**, 11 West River Road, B29, L4, Zone: GB *(Approved)*  
Proposed expansion of nonconforming use for sidewalk seating. Relief requested: use variances ("d(2)" and "d(3)"), permission for seating located on the public sidewalk, a design waiver for the seating enclosure, and relief from the minimum required distance between the curb and seating area.

- **#26-8113\_Cina**, 16 Harbor Drive, B111, L22 & 22.01, Zone: R-2  
Proposed improvements consist of additions to the principal building, rear covered porch, outdoor kitchen, pool, spa, and patios. Relief requested: a use “d” variance (FAR) and bulk “c” variances in connection with: lot coverage, building coverage, floor area, and setbacks from a waterway.
- **#26-8114\_Payne**, 25 Ridge Road, B100, L14, Zone: NB/R-4 *(Approved)*  
Proposed improvements consist of renovation and additions to the existing nonconforming principal/accessory buildings and driveway realignment. Relief requested: bulk variances in connection with side yard setbacks and parking within the front yard. Existing nonconforming condition to remain: detached garage located in the front yard.
- **#26-8115\_Serpe**, 36 East River Road, B11, L12, Zone: R-2 *(Approved)*  
Proposed improvements consist of new pool house. Relief requested: bulk “c” variance for side yard setback.
