INTRODUCTION OF ORDINANCE #25-002 CAPITAL ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS AND PURPOSES IN, BY AND FOR THE BOROUGH OF RUMSON, IN THE COUNTY OF MONMOUTH, NEW JERSEY.

The Municipal Clerk/Administrator read the following Ordinance by title only in first reading: 25-002

CAPITAL ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS AND PURPOSES IN, BY AND FOR THE BOROUGH OF RUMSON, IN THE COUNTY OF MONMOUTH, NEW JERSEY

WHEREAS, the Borough Council (the "Council") of the Borough of Rumson, in the County of Monmouth, New Jersey (the "Borough") has adopted a budget for the expenditure of public funds for capital purposes to give effect to general improvement programs; and

WHEREAS, the capital improvement appropriations have not heretofore been earmarked for specific purposes; and

WHEREAS, there is money available for the Borough's general improvement programs in the Capital Improvement Fund of the Borough (the "Capital Improvement Fund").

NOW THEREFORE, BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF RUMSON (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The Borough is hereby authorized to incur the following costs in connection with the following improvements and purposes: (a) public building improvements and equipment in the amount of \$100,000 and (b) various park improvements in the amount of \$400,000, including for each of the foregoing all work and materials necessary therefor and incidental thereto.

Section 2. The Borough hereby appropriates the sum of \$500,000 from the Capital Improvement Fund for the purpose of financing the costs of the improvements and purposes set forth in Section 1 of this capital ordinance. Upon the Borough's receipt of the proceeds of any grants related to the improvements and purposes set forth in Section 1 of this capital ordinance, all grant proceeds received by the Borough will be deposited in the Capital Improvement Fund.

Section 3. The said improvements and purposes described in Section 1 of this capital ordinance are lawful capital purposes of the Borough, and no part of the cost thereof has been or shall be assessed against property specially benefited thereby. The period of usefulness of said improvements and purposes is 16 years.

Section 4. The capital budget of the Borough is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board of the Division showing all detail of the amended capital budget and capital program as approved by the Director of the Division, are on file with the Municipal Clerk and are available for public inspection.

Section 5. This capital ordinance shall take effect after final adoption and publication as required by applicable law.

RESOLUTION AUTHORIZING A SHARED SERVICE AGREEMENT BETWEEN THE RUMSON-FAIR HAVEN BOARD OF EDUCATION AND THE BOROUGH OF RUMSON FOR THE USE OF BOROUGH RECREATION EQUIPMENT.

2025-0304-45

Councilmember Pomphrey offered the following Resolution and moved its adoption:

2025 SHARED SERVICES AGREEMENT BETWEEN THE RUMSON – FAIR HAVEN BOARD OF EDUCATION AND THE BOROUGH OF RUMSON FOR THE USE OF BOROUGH RECREATION EQUIPMENT

WHEREAS, the Rumson-Fair Haven Regional High school Board of Education ("Board") and The Borough of Rumson ("Borough") have worked in a cooperative spirit to meet the short and long term needs of each; and

WHEREAS, the Board and Borough have certain needs that are best served through shared services; and

WHEREAS, the Uniform Shared Services Consolidation Act, N.J.S.A. 40A:65-1 *et seq.*, authorizes and empowers the Board and Borough to enter into such Shared Services Agreement; and

WHEREAS, the purposes of the Board and Borough can be accomplished effectively through this Agreement; and

WHEREAS, the Board and Borough desire to enter into this Agreement; and

WHEREAS, each party to this Agreement have approved the execution of this Agreement by Resolutions adopted on March 4th, 2025 by the Borough and to be adopted by the Board.

NOW, THEREFORE THE PARTIES AGREE AS FOLLOWS:

- 1. <u>Scope of Services.</u> Borough agrees to provide the Board with boats/shells, oars, and other agreed upon equipment for rowing for all practices, meets, competitions and regattas for the Spring Crew/Rowing Season. The Borough will also provide oversite and collect Fees for the Spring Program. The Board will provide the Coaching Staff and the insurance for the Spring Program.
- 2. <u>Compensation</u>. The Borough will reimburse the Board a lump sum of \$23,055.89 for the Costs of Hiring and Managing Coaching for the Spring Rowing Season. Payment will be made by the Borough to the Board at the end of the season on or about June 1st, 2025.
- 3. <u>Maintenance and Inspections</u>. Maintenance of equipment is the sole responsibility of the Borough. Equipment is to be provided in good working condition and returned in like condition, with normal and customary wear. It is the Board's Employee's responsibility to report any and all issues relating to Borough equipment in a timely fashion. The Board or its representatives may not authorize or make any repairs or adjustments to equipment without Borough approval.

- 4. Other Agreements Unaffected. All other Shared Services Agreements whether currently existing or not, shall remain in full force and effect and shall not be governed by the terms of this Agreement.
- 5. <u>Standards.</u> The services provided through the use of this Agreement, shall be governed by the reasonable satisfaction standard, unless a different standard is specified in such Services Resolution.
- 6. <u>No Assignment.</u> The rights and obligations under this Agreement cannot be assigned by either party without the written consent of the other.
- 7. <u>Term of the Agreement.</u> This Agreement shall be for a term of one (1) Spring session ending on or about June 1st, 2025. Each party may cancel this Agreement, with ninety (90) days' written notice to the other party.
- 8. <u>Fees and Fee Shifting.</u> Attorneys' fees and fee shifting are prohibited under this Agreement and neither party may recover fees from the other party in the event of litigation or any proceedings brought to enforce the obligations of any party under this Agreement.
- 9. <u>Insurance</u>. The Board will provide Borough with a Certificate of Insurance naming the Borough as additional insured for the Spring Program as it relates to the Borough Site and/or Borough owned Equipment. Said Certificate will be a minimum of *2 million for Each Occurrence and 4 million for the General Aggregate*, as well as Automobile Coverage for the use of the Borough's boat trailer.
- 10. <u>Disputes.</u> The parties agree that in the event a dispute arises as to the interpretation of this Agreement, the Borough Administrator and Superintendent of Schools shall be notified. The Superintendent of Schools and the Borough Administrator shall immediately confirm the disputed issue and attempt to reach an accord. If the dispute cannot be rectified, the matter shall be submitted to mediation. Mediation shall be conducted, with costs to be equally divided by the Board and Borough. The New Jersey law shall govern this Agreement passed pursuant to the same.
- 11. <u>Efficiency and Public Benefit</u>. The parties concur that this Agreement is undertaken for the benefit of the general public of the Boroughs of Rumson and Fair Haven, that the Agreement is economically beneficial to the constituencies of each municipality.
- 12. <u>Severability</u>. If any clause, sentence, paragraph, section or part of this Agreement and shall be adjudged to be invalid in any Court of competent jurisdiction, such judgment shall not affect, impair, invalidate the remainder thereof, but shall be confined to the operation of the clause, sentence, paragraph, section or part thereof, directly involving the controversy in which such judgment shall be rendered.
