GARAGE SALE RULES & REGULATIONS

- A. TWO garage sales per person/premises will be allowed in one calendar year.
- B. NO sale shall extend beyond two days.
- C. Sale hours are limited from 9:00 a.m. to 6:00 p.m.
- D. Post Garage Sale Permit on premises where visible to Police.
- E.
 1. Garage Sale sign shall ONLY be posted on property where sale is being conducted.
 2. Garage Sale sign shall not exceed 2'X2' in size and must be removed within 24 hours after sale.
 3. NO POSTING OF SIGNS (Garage, Yard, Estate Sales, etc.) on ANY OTHER private or public property including utility poles, trees, etc.

NOTE: ANY PERSON VIOLATING THE ABOVE SIGN REGULATIONS IS IN VIOLATION OF BOROUGH ORDINANCES AND SUBJECT TO A FINE.
