 - Public Notice must be published in the Asbury Park Press or the Two River Times

*** AFTER ZONING BOARD DECISIONS ***

- 1. A Resolution will be memorialized at the <u>next</u> scheduled Zoning Board of Adjustment meeting. Meetings for the year are on the Zoning Board website.
- 2. The applicant will receive a copy of the signed Resolution approximately 7 days after it is memorialized.
- 3. In accordance with the Borough Ordinance 22-3.3e (5), It is the responsibility of the Applicant to make arrangements to post the Notice of Decision within 30 days of the memorialization of the Resolution. *Failure to publish shall render approvals null and void*. (Example attached).
- 4. Provide a copy of the published <u>Notice of Decision</u> and the <u>Affidavit of Publication</u> to the Zoning Board Secretary before moving forward.
- 5. The Zoning process begins again with a new complete Land Use & Development Permit application, a complete set of plans that were approved by the Rumson Zoning Board of Adjustment and a copy of the Resolution.
- 6. At a date commencing with the Public Notice of Decision, there is a 45-day public appeal period. The applicant may use this time to submit:
 - A new Land Use & Development Permit application, a complete set of plans that were final approved by the Zoning Board and a copy of the Resolution.
 - Engineering plans for Grading, Wetlands, Stormwater Management, and Floodplains Management approval.
 - Landscape plans (required for all new SFH) and Tree Removal permits.
 - It is upon the applicant to confirm whether additional permitting is required from other outside agencies.
- 7. At the end of the 45-day appeal period the applicant may request a refund of any remaining funds in Escrow by completing a Request For Release Of Escrow.
