Councilmember Casazza offered the following resolution and moved its adoption:

RESOLUTION AUTHORIZING CONTRACTS WITH CERTAIN APPROVED STATE CONTRACT VENDORS FOR CONTRACTING UNITS PURSUANT TO N.J.S.A. 40A:11-12a

WHEREAS, the Borough of Rumson, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the Rumson Police Department has the need on a timely basis to purchase goods or services utilizing State contracts; and

WHEREAS, the Rumson Police Department intends to enter into contracts through this resolution and properly executed contracts and purchase orders, with Insight Public Sector, 2701 E. Insight Way, Chandler, AZ 85286, authorized reseller for Computer Square Inc., 330 Mac Lane, Keasbey, NJ 08832 who holds New Jersey State Purchase and Property State Contract T-3121, 20-TELE-01512; and

WHEREAS, Insight Public Sector has provided for quote for Police Info CAD Software, Products, Services and Warranty under the authority of State Contract T-3121, 20-TELE-01512 in the amount of \$124,135.83, and

WHEREAS, Matthew Palmer, Chief Financial Officer for the Borough of Rumson has certified that free and unencumbered funds in the amount of \$124,135.83 are available in the 2025 and 2026 budgets for this purpose in account/line item number 5/6-01- -039-275.

NOW, THEREFORE, BE IT RESOLVED, that the Rumson Governing Body authorizes the Temporary Qualified Purchasing Agent to purchase certain goods or services from Insight Public Sector, authorized reseller for Computer Square Inc., pursuant to all conditions of the individual State contract T-3121, 20-TELE-01512, N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), and N.J.S.A. 19:44A-20.4 et seq.; and

BE IT FURTHER RESOLVED, by the Rumson Governing Body of the Borough of Rumson pursuant to N.J.A.C. 5:30-5.5(b), that the certification of available funds, shall either certify the full maximum amount against the budget at the time the contract is awarded, or no contract amount shall be chargeable or certified until such time as the goods or services are ordered or otherwise called for prior to placing the order, and a certification of availability of funds is made by the Chief Finance Officer; and

BE IT FURTHER RESOLVED that the duration of the contracts between the Rumson Police Department and T-3121, 20-TELE-01512 shall coincide with the term of the New Jersey Division of Purchase and Property contract dates.

RESOLUTION AUTHORIZING THE BOROUGH OF RUMSON TO JOIN THE NJ SOLUTIONS JOINT HEALTH INSURANCE FUND.

Councilmember Pomphrey offered the following resolution and moved its adoption:

RESOLUTION AUTHORIZING THE BOROUGH OF RUMSON TO JOIN THE NJ SOLUTIONS JOINT HEALTH INSURANCE FUND.

WHEREAS, a number of public entities in the State of New Jersey have joined together to form the NJ Solutions Joint Health Insurance Fund, hereafter referred to as the "<u>Fund</u>", as permitted by <u>N.J.A.C.</u> 11:15-3.1 <u>et. seq.</u>, <u>N.J.S.A.</u> 17:1-8.1 <u>et. seq.</u>, and <u>N.J.S.A.</u> 40A:10-36 <u>et. seq.</u>,; and

WHEREAS, the Fund was approved to become operational by the Department of Banking and Insurance and the Department of Community Affairs (collectively, the "<u>Departments</u>") and has been operational since that date; and

WHEREAS, the statutes and regulations governing the creation and operation of a joint insurance fund in the State of New Jersey contain certain restrictions and safeguards in connection with the administration of the public interest entrusted to such a Fund; and

WHEREAS, the governing body of The Borough of Rumson, hereinafter may be referred to as "Local Unit" has studied the feasibility of joining the Fund and has determined that membership in the Fund is in the best interest of the Borough of Rumson.

NOW, THEREFORE, BE IT RESOLVED that the governing body of the Borough of Rumson hereby agrees and authorizes the following:

- i. Execution of the application for membership to the Fund, including any and all documents and/or certifications as may be necessary, in order for the Borough of Rumson to complete the application process and join the Fund.
- ii. The Local Unit shall become a member of the Fund for an initial period outlined in the Borough of Rumson's Indemnity and Trust Agreement, subject to the approval of the Fund Commissioners, which in no event shall exceed three (3) years as prescribed in N.J.A.C. 11:15-3.3(a).
- iii. The Borough of Rumson shall participate in the following type(s) of coverage(s) offered by the Fund: Health Insurance and/or Prescription Insurance and/or Dental Insurance and/or Medicare Advantage/Employer Group Waiver Program as defined pursuant to N.J.S.A. 17B:17-4, the Fund's Bylaws, and Plan of Risk Management.
- iv. Adoption and approval of the Fund's Bylaws, a true and correct copy of which is annexed hereto as <u>Attachment A</u>, which has been approved by the Departments.
- v. Execution of the Borough of Rumson's Indemnity and Trust Agreement, a true and correct copy of which is annexed hereto as <u>Attachment B</u>, which has been approved by the Departments.

BE IT FURTHER RESOLVED that the governing body of the Borough of Rumson certifies, pursuant to N.J.A.C. 11:15-3.3(a), that the Borough of Rumson has never defaulted on claims under a self-insured plan and that it has not had its insurance canceled for nonpayment of premium for a period of at least two (2) years prior to this application.

BE IT FURTHER RESOLVED that the governing body of the Borough of Rumson is authorized and directed to execute the Indemnity and Trust Agreement and such other documents signifying membership in the Fund as required by the Fund's Bylaws, and to deliver these documents to the Fund's Executive Director with the express reservation that these documents

shall become effective only upon on acceptance of the Fund's By-laws as prescribed in N.J.A.C. 11:15-3.3(a).

BE IT FURTHER RESOLVED that this resolution shall take effect upon its passage.
