3.	Obtain list of all property owners within 200 feet of your property, as well as public utilities. A copy of the Public Notice should be sent to all property owners, and utilities, at least TEN (10) calendar days prior to the meeting. <i>Please contact the Board Secretary for this information.</i>	ALL CERTIFIED MAIL RECEIPTS (GREEN & WHITE SLIPS) MUST BE RETURNED WITH YOUR APPLICATION.
4.	Survey(s), Architectural Plan and Plot Plan. Survey must be prepared by a licensed professional current and show the property in its existing condition. Architectural Plans must include all elevations. Plot plan must include bulk schedule, setbacks and all proposed improvements.	12 COPIES
5.	Copy of the Public Notice. Must be published in the Asbury Park Press or the Two River Times. <i>NO LESS THAN TEN (10) DAYS PRIOR TO THE</i> <i>MEETING DATE.</i>	1 COPY
6.	Affidavit of Service, must be notarized.	1 COPY
7.	Affidavit of Publication from the newspaper.	1 COPY
8.	Proof of current taxes.	1 COPY
9.	Consent Form, if applicant is NOT the owner. Must be notarized.	1 COPY
