Re: Grant Avenue Force Main Failures - Emergency Repairs

On Sunday, May 7, 2023 the Department of Public works observed the probable failure of the 12° force main exiting the Grant Avenue Sanitary Sewer Pump Station prior to it crossing under the Shrewsbury River. The Borough immediately took emergency response action with the hiring of Precise Construction of Freehold to make emergency pipe repairs. The Borough also sourced emergency repair materials, retained trucking services to convey sewage into downstream sanitary sewer facilities in Sea Bright (where the 12° force main discharges) and dispatched Public Works Personnel to critical locations to assist the repair efforts. As we attempted repairs on Monday, May 8, 2023, it became apparent the pipe condition was far worse than we had previously encountered (May 2017 emergency force main repair). At approximately, 11 pm the repairs were completed enough that the Grant Avenue Pump Station could be reactivated and any leaks still occurring could be pumped back into the pump station wet well. We spent Tuesday, May 9, 2023 strategizing supplemental repair methods, sourcing materials and securing additional trucks to address the risk of sewage surcharge. On Wednesday, May 10, 2023 the force main repair was reattempted by rehabilitating the pipe exterior to accommodate a megalug clamp and then encasing the entire repair in concrete.

On Tuesday, May 16, 2023 the Department of Public Works observed another failure of the 12° force main in approximately the same location as just recently repaired. Precise Construction was again immediately engaged to complete the necessary repairs. Over the course of Wednesday, May 17, 2023 we again sourced emergency equipment, repair materials, retained trucking services for the conveyance of sewage and readied Public Works personnel for the repair activities. On Thursday, May 18, 2023, the area was excavated and the location of the pipe failure was located approximately 5' east of the previous repair. By late afternoon, the repair was complete and the Grant Avenue Pump Station reactivated. In an abundance of caution, the excavated area was left open overnight and monitored by Public Works. On Friday, May 19, 2023, it was confirmed the pipe repair had held overnight and the exposed pipe was encased in concrete to further improve the longevity of the repair. By Friday afternoon, the disturbed area was backfilled and leveled to match surrounding grade.

Throughout the two force main repairs, the New Jersey Department of Environmental Protection had Andrew Coleman, Environmental Specialist with Central Bureau of Water Compliance and Enforcement present to support our efforts and ensure environmental compliance.

The need to quickly repair the force main to avoid environmental catastrophe and maintain senitary sewer service to the Rumson Community was conducted on an emergency basis in accordance with N.J.S.A.40A:11-6 Emergency Contracts.

COMMENTS FROM THE COUNCIL:

Councilmember Pomphrey thanked everyone for their support and dedication to the Rumson Memorial Day Parade and Ceremony. Councilmember Kingsbery seconded this comment, and commended the keynote speaker, Garner Smythe, on his powerful speech.

COMMENTS FROM THE PUBLIC:

At this time, the Mayor invited the public to ask questions or make comments.

Dr. Ingrid Schweiger of 38 Warren Street addressed Mayor Hemphill and Borough Council at this time, stating that they were representing several neighbors.

Dr. Schweiger offered the following statement, supported and signed by residents on Warren Street:

Junii 13, 2023

Dear Council

At what point does a backyard pool project become a public and private nuisance? After away in Rumson peaceAuty for many years, our new neighbors at 36 Warren St. began working on a very ambitious, disruptive pool project for more than 2 1/2 years. The pool is now open and has become a magnet for neighborhood children in shifts at all hours of the day and evening as late as 11:30 pm accompanied by loud rep music, as well as racted music filled with obscenibles. This all occurs white under the supervision of the homeowners at 36 Warren.

A little background... approximately three years ago, the department of environmental protection contacted the four edjecent homeowners asking for feedback about this project. All four homeowners responded with well thought out letters opposing the project on environmental grounds due to the excessive flooding in the area as well as noise concerns since our backgards are quite small and extremely close to one another similar to condominium living. These letters opposing the project were also sent to members of the zoning board and several councilmen in Rumson. None of us received a response to any of the letters and the project was approved.

Fast forward 2.1/2 years and the pool is completed. Approximately % of the backyard around the pool has been raised 48 inches due to flooding concerns creating a situation where anyone around the pool appears to be 9 to 10 feet tall. An open recreational space underneath the ENTIRE footprint of the house will be completed soon which will result in additional noise and disruption.

The homeowners at 36 Warren are aware of the neighbors' disatisfaction regarding the noise and disruption. Many phone cells and texts have been made asking to lower the music and/or clear the pool. All of these requests have been ignored. It is not at all possible to use our backyards or decks as a result of the noise and the music. It is not possible to open a window in our homes without hearing music and shrinking in the pool.

The police were called three times in one week to remedy the situation, All times times the parents at 35 Warren were present in their home. The police officer suggested that

we call his department with all leaves that arise but we feel there should be urban

We are here tonight to ask the council for guidance and intervention. There exists a noise ordinance in Rutmon that states that the noise from one home should not interfere with another homeowner's enjoyment or use of their property. How is this noise ordinance enforced? At the moment, there is no way that we can use our decis or backyards. As Rutmon residents, we feel we deserve the right to use and enjoy our decks and backyards as well as the right to open up a window in our homes without hearing neighborhood music and disruption.

Lask the councit. Do you agree? At what point does this backyard pool and recreational space project become a public and private nuisance? What would you do if you were thing under these most unpleasant circumstances?


regarding the scope of the project. Dr. Schweiger expanded the issue join statement, commenting on the continued work on the property in question and the disruption it

is causing, despite the repeated attempts to connect with the property owner. Borough Engineer David Marks stated that he would like to conduct more research before officially commenting on any specifics of the project. Dr. Schweiger stated their support for the Rumson Police Department, applauding the response to calls and noise violations. Mayor Hemphill and members of Borough Council thanked Dr. Schweiger for their comments, stating The Borough officials will work towards responses to the questions.

Nancy Herron of 34 Warren Street addressed Mayor Hemphill and Borough Council at this time. Herron followed Dr. Schweiger's comments stating their concern with the pool, and in connection noise, provided by the home in question. Herron was told they are also welcome to call the Rumson Police Department with any questions and concerns. Herron asked for clarification on details of the Borough of Rumson ordinance and was advised that the details of The Borough of Rumson ordinance can be found on The Borough's website, www.rumsonnj.gov. Councilmember Casazza questioned the process of issuing a summons and was informed by The Borough attorney, Martin Barger, that summonses are done by the police. Herron concluded by stating the dialogue with the homeowner is difficult. Mayor Hemphill and members of Borough Council thanked Nancy Herron for their comments, stating The Borough officials will work towards responses to the questions regarding ordinance and zoning.

Stuart Sendell of 7D Lafayette Street began by congratulating Councilmember Casazza on his victory during the primary election. Mr. Sendell continued by commenting on the information listed on The Borough of Rumson website, which states there is two council meetings, as well as three potential workshops, in a given month. Further, Mr. Sendell commented on drivers and bicyclers that are still not following the one-way traffic pattern for Lafayette street, stating that many continue to travel dangerously against the one-way traffic. Mr. Sendell recommended stationing a police officer as he feels the current conditions will cause a serious accident on one of the adjacent streets. Mr. Sendell concluded their public comment with the following statement:



Council President Conklin stated that he appreciates all the hard work The Borough officials are putting into the Rumson Affordable Housing Program. Mayor Hemphill thanked Mr. Sendell for his comments.

ADJOURNMENT:

Councilmember Lospinuso made a motion to adjourn the meeting which was seconded by Councilmember Casazza. The meeting adjourned at 8:18 p.m. All in favor.
